

MCPS FRAMEWORK




Reverse Linkages

How are MCPS and RLs Linked?




Special Funds, Programs & Initiatives



Islamic Solidarity Fund for Development (ISFD)

- Dedicated facility to fight poverty
- Target Endowment of US\$ 10 billion
- Flagships: Integrated Community Driven Development (ICDD), Vocational Literacy (VOLIP), Microfinance, Sustainable Villages



Special Program for the Development of Africa (SPDA -I)

- Aims to support investments in social & infrastructure sectors in Sub-Saharan Africa
- Total Size: US\$ 12 billion (US\$ 4 billion from IDB Group) over 5 years (2008 – 2012)



Jeddah Declaration on Food Security

- Supports Member Countries affected by the global food crisis (2008 – 2012)
- Total IDBG : US\$ 1.5 billion over 5 years
- Meeting both urgent, medium and long term needs of mainly LDMCs



Youth Employment Support Program in Arab Countries

- High-level of Unemployment amongst Youth in Arab Countries identified as one of the key causes for recent political turmoil and unrest
- Initial Size: US\$ 250 million
- Areas: Micro-Finance, Vocational Training, Entrepreneur development, MSME Development, advisory services



Education for Employment: Realizing Arab Youth Potential (E4E)

- Joint initiative between IDB and International Finance Corporation (IFC) – World Bank Group

- To Tackle youth un-employment
- To Unleash the potential of Arab Youth
- To use the private sector as a powerful force for positive change
- To jointly mobilize US\$ 1.5 – 2.0 bill. for E4E programs
- Egypt & Tunisia programs under preparation (Initial Projects of US\$ 50 mn)




IDB Group and Malaysia

- Malaysia joined IDB on August 12, 1974 as a founding member;
- Malaysia and IDB have been development partners for the last 38 years;
- IDB has a Regional Office in Malaysia;
- Total IDB Group 177 Operation for a total amount of US\$ 1.43 billion-The first IDB operation in Malaysia was approved on 8/9/1977 (Pahang Cement Sdn. Bhd., equity).
- Joint capacity building programs for OIC Member Countries.

IDB Group Intervention in Malaysia (Total US\$ 1,434 million)


**1396H-1432H
