
MISION

The utilization of raw water for drinking water supply to Bandung Regency and Cimahi City is 400 liters / sec.


WSS Region of Cirebon Raya



The utilization of raw water from Jatigede Reservoir for Water Supply to Cirebon, Indramayu, Majalengka and Sumedang is 1500 liter / second.




